## NEWS OF THE WEEK.

### CRIMES AND CRIMINALS.

H. R. Webb of Newport, Arkansas, confined of an attempt to outrage a girl who had been engaged to marry him, and to the publicity for 21 years. John Stenger, Jr., "business manager" of the Southern Dispatch of Louisville, Ky., has disappeared, taking with him several thousand dollars of the company's money.

The jury in the case of James L. Seigler, late editor of the First National bank at Indianapolis, Ind., on its trial in the United States court, before Judge Bogert, on a charge of embezzlement, returned a verdict not guilty.

### CASUALTIES.

A fire in Detroit, Mich., March 23rd, destroyed several stores. Loss \$170,000.

By the falling of a bridge over the Waterway Valley railroad near Cambridge City, Ind., Adam Dexter was fatally injured, George Davis an arm broken and John Lewis and Charles Gallagher were severely injured.

The family in Upper Egypt caused terrific famine. The famine in the Nile valley was so severe that the people were asked, "are you like wild beasts, if for food?" One town the women and children sought out scraps of refuse and were said to be starving like dogs.

A terrible plague of locusts recently occurred in Republic and Cloud counties, Kansas. They extended over an area ten miles long and three miles wide, and were very voracious before them. It is said that one hundred boxes were consumed, also large quantities of grain, farming implements, hay and other property. The winds were so high and the locusts so dense that the inhabitants were obliged to take refuge in cellars dug out of underground habitations. But one life is reported lost. After a week the locusts were reported to be dead while attempting to reach some lower form of life. The locusts covered several towns were severely injured. Loss estimated at \$400,000.
